Dit verzekeringsproduct bevordert sociale of milieukenmerken

Dit verzekeringsproduct maakt de volgende soorten beleggingsinstrumenten (opties) mogelijk:

- Externe fondsen die Instellingen voor Collectieve Belegging in Effecten (ICBE's) zijn;
- Interne collectieve fondsen (ICF);
- Interne speciale fondsen (ISF);

Het financiële product biedt de verzekeringnemer de mogelijkheid om te beleggen in een selectie van deze beleggingsinstrumenten, met inbegrip van die welke, in overeenstemming met de Verordening betreffende informatieverschaffing over duurzame financiering (SFDR): (i) milieu- en/of sociale kenmerken bevorderen (artikel 8), (ii) duurzame beleggingen als doelstelling hebben (artikel 9) en (iii) geen van beide (i) of (ii) doen (artikel 6). De mate waarin een individuele polis milieu- en/of sociale kenmerken bevordert, hangt af van de keuze van beleggingsinstrumenten door de polishouder.

In de onderstaande tabel staan deze beleggingsinstrumenten vermeld die zijn geclassificeerd als SFDR artikel 8 of 9.

Aan deze milieu- of sociale kenmerken of duurzame beleggingsdoelstelling wordt alleen voldaan wanneer het verzekeringsproduct in ten minste één van de onderstaande beleggingsopties belegt en ten minste één van die opties gedurende de looptijd van het financiële product wordt aangehouden.
