This insurance product promotes social or environmental characteristics

This insurance product allows the following types of investment vehicle (options):

- External funds being undertakings for collective investment in transferable securities (UCITS);

- Internal Dedicated Funds (IDF);
- Specialised Insurance Funds (SIF) (only upon request and subject to prior approval by OneLife).

The financial product allows the policyholder to invest in a selection of these investment vehicles, including those that, in accordance with the Sustainable Finance Disclosure Regulation (SFDR): (i) promote environmental and/or social characteristics (Article 8), (ii) have a sustainable investment as an objective (Article 9) and (iii) do neither of (i) or (ii) (Article 6). The extent to which an individual policy promotes environmental and/or social characteristics depends on the investment vehicle choices of the policyholder.

The table below lists these investment vehicles that are classified as SFDR Article 8 or 9.

These environmental or social characteristics or sustainable investment objective will only be met where the insurance product invests in at least one of the investment options mentioned in the list below and that at least one of those options is kept during the holding period of the financial product.
